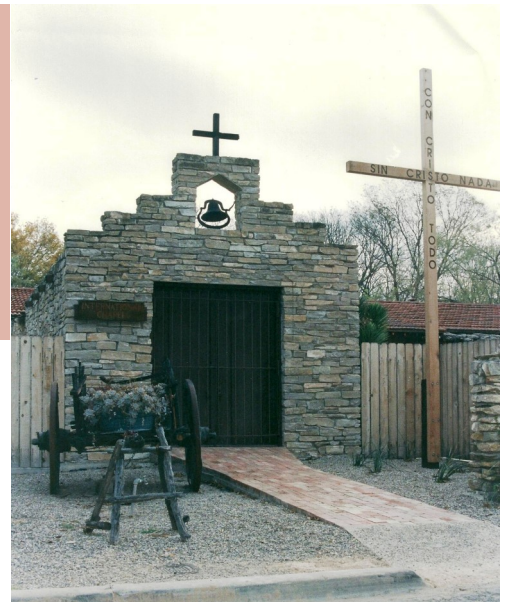

Rental agreement on a reservation basis only, by and between Whitehead Memorial Museum, a non-profit corporation of the City of Del Rio and Val Verde County, acting by and through the Director of the Association for the Director of the Whitehead Memorial Museum Chapel use, hereinafter called "LESSOR" fully described below:

A non-refundable fee of \$50.00 must be paid in full at time of reservation for the Chapel. This is a flat rate good for thirty (30) minutes. Additional rental time is in thirty (30) minute increments at \$50.00 per half hour. I understand that if I cancel, the fee will not be refunded. \_\_\_\_\_ (Initial)

The "LESSEE" will be assessed a \$25.00 service charge on each returned check. \_\_\_\_\_ (Initial)

"LESSEE" is authorized to move, remove or rearrange pews and chairs to their own needs with the condition they are returned to their original place. However, exhibit items on the front altar may not be moved or altered. \_\_\_\_\_ (Initial)

All persons setting up for or attending your function should not tour the Museum without paying the admittance fee. \_\_\_\_\_ (Initial)

The "LESSEE" is responsibility for insuring that all function participants leave by the end of the contracted time. Should guests/participants stay past the contracted time, the "LESSEE" will be responsible for paying these fees before leaving the museum. \_\_\_\_\_ (Initial)

All items brought onto the museum grounds are to be removed by the "LESSEE" at the end of the function. The "LESSEE" not the "LESSOR" is responsible for any lost, stolen or damaged items. The "LESSEE" will pay for all damages prior to leaving the grounds. \_\_\_\_\_ (Initial)

I understand that if I fail to meet any or all of the above conditions that I will be subject to applicable charges as mentioned in this contract. Failure to comply with the conditions of this contract may result in the filing of criminal charges. Photos/video may be taken by museum staff for promotional use. \_\_\_\_\_ (Initial)
